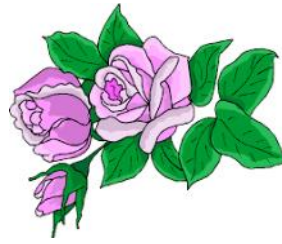

Spoiler alert – I saw Marian Deutschman's article before I started writing this. And I would like to commend her for speaking out with her friends in support of the victims of sexual assault who have not been believed.

I had an experience a month or so ago and I am still torn over the way I didn't respond. I was waiting for the arrival of the woman who cuts my hair. There were only two other people in the place – another stylist and her customer. This was just before the Alabama special election and they were talking about the Judge Moore situation. Both of these women were younger than I, probably 35-40ish. They were firmly on the side of the judge, saying things like "why would these women wait so long – they must be lying." I was so tempted to respond with something like "Does the name 'Anita Hill' mean anything to you? Remember what she went through when she came forward with her experience?" But I said nothing, which I rationalized for several reasons – both women were too young to remember that

AND one was a customer of the shop and I would not want to antagonize the customer of a local business AND I didn't think they would have cared what I had to say since they had already made up their minds.

Should I have said something? I'm still not sure.

There is one other thing that haunts me. I think of the women who accused President Clinton of inappropriate behavior and how many of us CHOSE not to believe them – or consider it important – because we liked his political actions. Wrong is wrong, and many of us did not handle that well.

On a brighter note – a message went to the branch website just about the same time from a local writer who wanted to interview an AAUW member about sexual harassment. Our organization is known for its knowledge of womens' issues! I did speak with her and this month happened to see the publication – the January issue of "In Good Health" - and I was quoted a couple of times.

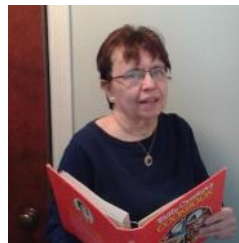
EMERGING LEADER

PUBLIC POLICY: #MeToo #TimesUp #HerToo

At a recent holiday social event, I was outnumbered by women who believed that the majority of women, who claimed to be sexually assaulted or sexually harassed by famous men, were lying. I asked them why a woman would make these claims when it takes so much courage to step forward. They responded that these women were paid and wanted their few minutes in the spotlight of publicity.

Some say that the current frenzy to expose sexual harassers is largely a reaction to Trump's election. Trump, like Roy Moore in Alabama, has called his accusers liars. The #MeToo hashtag, adopted by women to share their stories of sexual abuse, harassment, and abuse, began on Oct. 5, when *The New York Times* reported the first allegations of sexual harassment against Hollywood producer Harvey Weinstein. By early November, #MeToo became global with over 2.3 million tweets in 85 countries and shared in over 77 million posts or comments on Facebook. In three months, #MeToo has gone from being a viral hashtag to *Time* magazine's Person of the Year, recognizing claims of sexual harassment and assault as one of the biggest stories of 2017. The #MeToo movement has empowered women to hold tormentors accountable for their abuses.

As the year ended, more than 300 women in Hollywood, including executives, actors, agents, writers, directors, and producers, announced the formation of Time's Up, an effort to counter systemic sexual harassment, not just in the entertainment industry, but also in industries across the country. It is an effort that aims to combat workplace sexism through legal recourse. The initiative includes efforts to create legislation that will penalize companies that tolerate harassment, and that will discourage the use of the nondisclosure agreements that have helped to silence victims of abuse.

Hashtag #MeToo has emphasized the personal and the anecdotal, and #TimesUp embraces the political by attempting to expand the fight against sexual harassment and the workplace inequality that has allowed it to flourish for so long. To share one's own story is both an act of bravery and an act of privilege. While many have spoken up, many more have not because the risks of doing so are too severe.



Time's Up's mission statement is too long to print here but it includes several answers to the question of "What You Can Do": If a person who has been

harassed tells you about it, believe them. Don't underestimate how hard it is to talk about these things. Connect them to resources that can help. Mentor someone from an under-represented group in your industry. You can support those affected by sexual harassment by donating to the Time's Up Legal Defense Fund.

Unicef's #HerToo initiative is about our deepest desire to ensure the dignity of every woman and girl. Globally, 90% of adolescent girls who have been sexually abused know their attacker. Fifteen million adolescent girls worldwide between age 15 and 19 have experienced rape or other sexual abuse. Nine million girls have experienced sexual abuse in just the past year. Only 1% of them reached out for help.

There is a big job to be done that starts with believing.
