3. Announcements

- The EH&S have changed the Food Permit Policy.
 - All food not ordered through Three Pillars will be required to have a food permit. This includes UB Market Place, other Campus Dining & Shops (CDS) entities and any other on-campus food vendor.
 - This is a departure from last semester in which vendors located in the Student Union and the Commons (i.e., La Rosa and Tim Horton's) were considered on-campus and did not require a food permit.
 - Please be sure to plan events accordingly, as food permit applications must be submitted at least two weeks in advance of your event. GSA cannot process any requisition requests for on-campus food without an approved food permit, so events may need to be planned a month in advance in order to secure all of the necessary approvals.
- AudienceView, the third-party vendor used by the UB Ticket Office, has had a software breach.
 - The University was informed on February 22nd of a data breach by the vendor. UB was not the only university impacted.
 - o It was originally believed that only data from February 17th-21st was impacted, but they now believe the breach was more wide-spread.
 - The vendor has completely shut down the website, software and sales for a minimum of 5 to 7 business days.
 - We are waiting to hear from the vendor about their full remediation plan, but we expect it to include free credit monitoring for involved parties for 3 years.
 - We are in the process of working with the University to find an alternate, temporary solution to allow us to continue selling tickets and merchandise. We will potentially use UB Marketplace, with surcharges waived.
 - We will keep everyone notified via email, the GSA website and our social media accounts as more information and/or details become available.
